- 1) Fishing for Smiles –Fred Herring spoke about the event. Articles put in Miner, Standard, Radio stations. - 1) Stan Snow – Plans to improve the 1000 yard range. Proposing to move the stairs from the side that has been condemned and put them so they can be used for a way up to the platform. Also would like to enlarge the parking lot. Also the berm at the 1000 yard parking lot needs to be enlarged. Would like to move the silhouette shoot to the 1000 yard. Stated the scrap metal has the abrasion resistant steel for .58 cents per pound. Would like to get approval to get started. Fred asked for incremental plan to see what we need. Farren made motion that we give \$400.00 for them to put in the pad. Fred asks for plan to be submitted. Matt Shwartzkoff stated he is pretty sure but he will have to check that there has already been an environmental study that cleared us to enlarge the parking lot. Also has done the environmental clearance to put stairs. He will check what has been cleared. Game and Fish would really like to see the end with the rebar sticking out be the first thing taken care of as that is a huge liability. Matt states he would like to work with Stan to put together a plan. Stan states he would like that. Matt states the days of going out and putting up forms and pouring concrete are over due to the liability and the lawyers. Motion made by Farren to work with fish and game and table this decision and the work on the 1000 yard until we can hear something back from Stan and Matt. Vicki Seconded motion.
- 2) Jim Merritt – 1000 yard targets. Paper targets are no longer available. Electronic targets are taking over and everyone is going to those. They are \$750.00 each they come in a pack of 4. Have to make some brackets to put them up. For an intermediate on the targets Larry Stephey had found a place that can print vinyl targets and then they will need to make stands to hang them on. Jim would like to get \$500.00 approved for getting the vinyl targets and wood for the stands. Matt stated he can put them in touch with the person to talk about the electronic targets. Matt would be more than willing to have anyone come to the Ben Avery range to see their set up. He states there is no one who is making the paper targets anymore. Matt states the electronic targets is the way to go. Jim asks for a motion of \$500.00 to get the vinyl targets and the supplies needed. Vicki made the motion. Fred seconded. All were in favor. Farren made motion to table the money on the electronic until further information can be given. Fred seconded.
- 3) Sig Sauer incident – Vicki read the email from Williams sporting club. Matt stated he has already put together a response to that email as he received the same email. Where do we draw the line? Board decided to disregard making any kind of ban and Matt will send email to them.
- 4) Clays for CTC – Vicki gave report of how many much it will cost for the clays to be ordered. Jim makes motion to buy clays and Farren seconds. Matt states Flagstaff is ready to order. He will get ahold of them
